As of April 1, 2023, BC Hydro has 125 Electricity Purchase Agreements (EPAs) with IPPs whose projects achieved commercial operation, as defined in their EPA and are considered to be in operation. In total, these projects are capable of delivering approximately 18,872 gigawatt hours of annual supply and approximately 5,376 megawatts of capacity.
