

# BC HYDRO WINTER SAFETY QUIZ CONTEST OFFICIAL CONTEST RULES NO PURCHASE REQUIRED

#### 1. CONTEST PERIOD:

British Columbia Hydro and Power Authority ("**BC Hydro**") Winter Safety Quiz (the "**Contest**") begins on November 6, 2023 at 12:00 a.m. Pacific Time ("PT") and ends on December 10, 2023 at 11:59 p.m. PT (the "**Contest Period**").

#### 2. ELIGIBILITY:

The Contest is open to all residents of British Columbia who have reached the age of nineteen (19) years at the time of entry and otherwise comply with these Official Contest Rules (the "**Contest Rules**"). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

#### 3. HOW TO ENTER:

NO PURCHASE REQUIRED. To enter for a chance to win, complete the following steps during the Contest Period:

#### 5. WINNER SELECTION:

A random draw will be conducted on December 11, 2023.

#### 6. WINNER NOTIFICATION:

Before being declared a winner, BC Hydro will contact the selected entrant via the e-mail address used by that selected entrant to submit a Contest entry. Once BC Hydro has contacted the selected entrant by email, the selected entrant is required to (a) correctly answer a time-limited mathematical skill-testing question without mechanical or other assistance and (b) sign and return a Declaration, Consent, and Release form which confirms compliance with these Contest Rules, acknowledges acceptance of the prize as awarded, and releases BC Hydro from any and all liability in connection with this Contest and the prize. BC Hydro will make at least three (3) attempts over the ten (10) days following the draw to contact the selected entrant. If the selected entrant cannot be contacted, fails to correctly answer the mathematical skill-testing question, fails to complete and return the Declaration, Consent, and Release form within five (5) business days after being contacted, or cannot accept the prize for any reason, then at BC Hydro's sole discretion, that selected entrant will be disgualified and another entrant will be selected by random draw from remaining eligible entries.
