Please note: a minimum of 150 square feet must be installed in each location. If applying for the Bonus Offer, the square footage installed in any one location must amount to a minimum \$300 rebate.

**Draftproofing** A pre- and post-Upgrade EnerGuide home evaluation is required. Your energy advisor will assist you with the completion of the Form A: Bonus Offer and Draftproofing and submit it on your behalf.
