British Columbia Hydro and Power Authority (BC Hydro)
F2007/F2008 Revenue Requirements Application**

Enclosed as Exhibit B-11 are 1,217 BC Hydro responses to BCUC Information Request (IR) Round 1 and Intervenor IR Round 1. The outstanding IR responses will be filed on Thursday, August 3, 2006. Appendix A lists these outstanding IRs.

BC Hydro notes that its responses in this first round of information requests are based on its application as filed, generally without inclusion of more current information, unless specifically requested and available. In this regard, BC Hydro will be making a proposal regarding an evidentiary update at the Second Procedural Conference on August 1, 2006, which will address, among other things, the revenue requirement consequences of its recent re-organization, cost of energy forecast updates, and F2006 actual results.

BC Hydro was not able to or unwilling to provide full answers to a very small number of IRs, for reasons described in the IR response. Similarly, BC Hydro has in a very small number of cases provided documents with redactions, again for reasons provided in the IR response.

BC Hydro requests that if intervenors have any issues regarding adequacy of responses to their IRs that these be taken up with BC Hydro directly, before making any motions to the BCUC. Such issues can be sent to: regulatory.group@bchydro.com.
