General Service E-Plus rate amendments filed with the BCUC

In June 2019, we notified you that the General Service – Dual Fuel (Closed) rate (Rate Schedules 1205, 1206 and 1207; referred to as the General Service E-Plus rate) will not be available to you beyond March 31, 2023.

To help customers with the transition, including **removing some restrictions and customer obligations**, we submitted a filing to the British Columbia Utilities Commission (BCUC) on November 14, 2019 to request approval of the following changes to the General Service E-Pus rate:

- General Service E-Plus service will no longer be interruptible (remove Special Conditions 1 and 3):
- You will no longer be required to maintain a permanent back-up heating system (remove Special Condition 2);
- You will be able to replace your existing heating system with a more energy efficient system while remaining eligible for the General Service E-Plus rate until March 31, 2023 (proposed new Special Condition 5); and
- Remove sections that no longer apply to any existing customers to improve customer understandability (Special Conditions 6, 7, 10, 11 and 12).

However, the General Service E-plus rate will continue to be available only for space, water and industrial process heating during the interim and new or additional load cannot be added to the service until the transition on April 1, 2023.

Based on your annual historical electricity use between April 1, 2018 and March 31, 2019 (Fiscal 2019) and if your usage remains similar in the future, your account will be transitioned to the Small General Service (Rate Schedule 1300) rate on April 1, 2023.

The following table provides the estimated minimum, average and maximum bill impact per customer after transitioning to the applicable General Service rate on April 1, 2023 using Fiscal 2019 annual historical billing information. It also includes a forecasted cumulative general rate increase of 6.2% through April 1, 2023.

| Rate Schedule | Minimum % | Average % | Maximum % |
|---------------|-----------|-----------|-----------|
| 1205 | 0% | 65% | 147% |
| 1206 | 0% | 78% | 159% |
| 1207 | 19% | 124% | 166% |

The BCUC invites public input and comments to ensure all perspectives are carefully considered prior to making a decision on rate applications.
