**RE: British Columbia Utilities Commission (BCUC or Commission)
British Columbia Hydro and Power Authority (BC Hydro)
Site C Clean Energy Project
COVID-19 Impact and Risk Mitigation Bi-Weekly Report No. 33**

BC Hydro writes in response to the BCUC's letter dated April 1, 2020 (the **Letter**) to provide a bi-weekly update on the current status of the COVID-19 Pandemic situation on the Site C Project.

In the Letter, the BCUC asked for:

1.0 An update on the current status of the Pandemic situation on-site, including numbers of workers who: have ceased work on the Project; those who continue to work on the Project; and anyone who remains on-site, but who is not actively working on the Project. Also, any confirmed Pandemic cases to-date, and the work status and location of these individuals. We request an update to this information on a bi-weekly basis while the Provincial State of Emergency in British Columbia remains in effect.

2.0 **BC Hydro Response**

BC Hydro reports the total number of workers on site as a whole and does not distinguish between the project work areas. There is an approximate four to six-week lag from when BC Hydro receives this information as it is collected and reported from the contractors on the Site C Project.

On July 6, 2021, BC Hydro released the Site C employment report for May 2021. The latest statistics show there were 4,868 total workers on the Site C project in May 2021.

Since the last bi-weekly report, BC Hydro confirms that there have been no new COVID-19 cases. Since March 2020, BC Hydro has been notified of 128 people testing

positive for COVID-19 while working on the Site C Project. As of July 13, 2021, there are zero active cases of COVID-19 on the Site C Project and 128 cases that have cleared.

Northern Health has notified BC Hydro that BC Hydro's approach to isolation requirements for fully vaccinated workers can change going forward. Close contacts will no longer have to isolate if a full week has passed since they received their second vaccine dose and no exposures occurred within that seven-day period. Even with the change in policy, BC Hydro remains very cautious and continues to apply all public health guidelines. As of July 13, 2021, there are two people in isolation in the camp under the medical supervision of the on-site health clinic and three people are isolating at home.

On July 8, 2021, the BC Provincial Health Authority issued a revised industrial camp order allowing for the relaxation of several COVID-19 measures. Changes that are now in effect include: workers are no longer restricted to camp during their rotation and mask use will no longer be required in certain areas on site. BC Hydro is not immediately restarting the shuttle bus service but is looking at resumption of the service in the near future, masks are still required for common areas of camp and daily health screening remains in place at the security gates.

As of July 13, 2021, a total of 3,098 vaccines have been administered, including 1,344 second doses. This figure does not include workers who have been vaccinated in their home communities.

BC Hydro continues to work with the Northern Health Authority and strictly follows all federal and provincial health guidelines to protect other workers in the camp and the local community.
