British Columbia Utilities Commission (BCUC or Commission)
British Columbia Hydro and Power Authority (BC Hydro)
Fiscal 2020 to Fiscal 2021 Revenue Requirements Application

BC Hydro writes further to BCUC Order No. G-146-19, which directed BC Hydro to inform the BCUC when the Government of B.C.'s Public Accounts are released, if released prior to August 30, 2019, and to provide the BCUC with a date for the completion of the Evidentiary Update. The BCUC stated that "[t]he Panel, at that time, may issue a revised regulatory timetable to reflect these new dates."

BC Hydro advises that the Government of B.C.'s Public Accounts were released on Thursday, July 18, 2019. BC Hydro now expects to be able to file the Evidentiary Update by Thursday, August 22, 2019, which is shortly after the forecast underlying the Evidentiary Update would be reviewed and approved by the Audit and Finance Committee of BC Hydro's Board of Directors.

BC Hydro would also like to take this opportunity to request that the BCUC consider advancing the date of the second Procedural Conference, which is intended to address the scope of the oral component of this proceeding.

The Procedural Conference is currently scheduled for December 19, 2019, one of the last working days before Christmas. Considering the holiday break, this date would provide limited time between the BCUC's decision on the scope of the oral hearing and the start of the hearing on January 20, 2020 and would severely limit the amount of time available for BC Hydro to finalize and prepare our witness panels.

In Exhibit B-8 providing comments on procedural matters, BC Hydro outlined the benefits to BC Hydro and customers alike of identifying specific issues to define the scope of an oral component for this proceeding. These benefits included avoiding the use of valuable institutional capacity to prepare for any number of matters that do not

end up getting addressed in an oral hearing and enabling BC Hydro to focus its preparation so that the BCUC receives better evidence and areas of the organization that are not directly involved in the specific issues will be able to re-focus their efforts on running the business.

BC Hydro is concerned that the current timetable diminishes these benefits due to the limited time between the BCUC's decision on the scope of the oral component and the start of the oral hearing on January 20, 2020.

Accordingly, BC Hydro requests that the BCUC advance the second Procedural Conference to the week of November 25, 2019. BC Hydro recognizes that this date would be before the filing of Intervener Evidence, but is of the view that intervener evidence would likely be within the scope of the oral phase of a hearing. BC Hydro is not opposed to an early determination by the BCUC that Intervener Evidence should be within the scope of the oral phase.

BC Hydro has canvassed those interveners representing our major customer groups with regards to this proposal. BC Sustainable Energy Association, Clean Energy Association of B.C., Commercial Energy Consumers Association of British Columbia, MoveUp and the Zone II Ratepayers Group support advancing the date of the second Procedural Conference. The Association of Major Power Customers of British Columbia do not support advancing the date. At the time of this letter, we have not heard back from the British Columbia Old Age Pensioners Organization et. al.

The following table provides a proposed timetable that reflects an Evidentiary Update filing on August 22, 2019, consequential changes to the dates for the filing of BCUC and intervener Information Requests and BC Hydro responses on the Evidentiary Update, and a second Procedural Conference during the week of November 25, 2019. BC Hydro also notes that it is not requesting to advance the date for the commencement of the Oral Hearing as this would negate the benefits of an earlier Procedural Conference.
