## RE: British Columbia Utilities Commission (BCUC or Commission) British Columbia Hydro and Power Authority (BC Hydro) Fiscal 2022 Revenue Requirements Application

BC Hydro writes to advise that it will be filing its Fiscal 2022 Revenue Requirements Application on December 22, 2020 (**Application**) and to propose a regulatory process for the review of the Application.

During the proceeding on BC Hydro's Fiscal 2020 to Fiscal 2021 Revenue Requirements Application, the BCUC expressed a desire to realign the timing of BC Hydro's future Revenue Requirement Applications. The goal is for applications to be submitted earlier so that there is enough time remaining in the period under review for BC Hydro to implement directives within that period. BC Hydro and a number of interveners supported this objective.

In order to achieve this outcome, the BCUC directed BC Hydro to file a one-year Revenue Requirements Application for fiscal 2022 by December 2020, to be reviewed through a streamlined process. Streamlining the fiscal 2022 process will realign the timing of BC Hydro's future Revenue Requirements Applications, starting with the Revenue Requirements Application for fiscal 2023 and subsequent fiscal years.

To support a streamlined process, BC Hydro provides the following proposal for the review of the Application. The proposal broadly follows the model used by FortisBC in its Annual Reviews, which was the concept put forward by the Panel for comment during the Fiscal 2020 to Fiscal 2021 Revenue Requirements Application proceeding.<sup>1</sup> It achieves the objective of enabling the BCUC to issue its Decision with enough time remaining in the test period for BC Hydro to implement directives within that period.

We recognize that the timetable is compressed and will be a challenge for all participants. However, delaying the end date of the proceeding, and as a result delaying the decision date, will pose significant challenges to BC Hydro being able to reflect the results in the Fiscal 2023 Revenue Requirements Application.<sup>3</sup>

BC Hydro is planning to file its Fiscal 2023 Revenue Requirements Application in August 2021 so that actual fiscal 2021 results can be reflected in that application. To reflect the results of this proceeding in the Fiscal 2023 Revenue Requirements Application, BC Hydro would need to receive the BCUC's Decision by no later than the end of June 2021.
