BC Hydro writes in compliance with Directive 2 of the Commission Order No. G-334-20, dated December 15, 2020 in respect of our application requesting approval of a transition tariff agreement as TS 100 between BC Hydro and Canfor for service to its facilities located at the Chetwynd sawmill division (**Application**).

On December 24, 2020, BC Hydro filed a request with the BCUC to extend the deadline to provide notice of the Application to its Large General Service (**LGS**) customers. The BCUC issued Order No. G-351-20, dated December 29, 2020 amending the regulatory timetable, to allow time to complete the task of providing notice of the Application and Order by January 15, 2021.

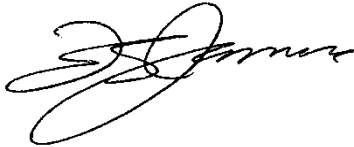
BC Hydro notes that there are approximately 4,000 LGS customers. Of these, we have email addresses for only approximately 3,000, and we provided these customers with notice of the Application and Commission Order No. G-334-20 on December 21, 2020. However, for those customers with no email address, a letter was mailed out using regular post to approximately 1,000 remaining customers by January 7, 2021.

Transition tariff agreement between BC Hydro and Canfor

On November 16, 2020, we submitted our application to the BC Utilities Commission (BCUC) to approve Tariff Supplement No. 100 between BC Hydro and Canfor (British Columbia Hydro and Power Authority – Canadian Forest Products Ltd. – Chetwynd Division) for service to its facilities located at the Chetwynd sawmill division.

This transition tariff agreement will allow Canfor to continue being billed under the Transmission Service rate (Rate Schedule 1823), plus rate rider, for ten years. At the end of the ten-year agreement, Canfor will be transitioned to the applicable Large General Service rate.

We're regulated by the BCUC and under the Utilities Commission Act, the BCUC's responsibilities include ensuring that customers receive safe, reliable and non-discriminatory energy services at fair rates from the utilities it regulates. This includes making decisions on agreements such as this.

It's important to know that this agreement will not impact the rates you pay. However, the BCUC has requested that all customers with service on the Large General Service rate be notified of the application and regulatory timetable.
