# OFFICIAL CONTEST RULES NO PURCHASE REQUIRED

# 1. CONTEST PERIOD:

British Columbia Hydro and Power Authority ("BC Hydro") "Emergency Prep Social Media" Contest (the "Contest Rules") begins on February 5, 2025 at 4:00 p.m. Pacific Time ("PT") and ends on March 3, 2025 at 11:59 p.m. PT (the "Contest Period").

# 2. ELIGIBILITY:

NO PURCHASE REQUIRED. The Contest is open to all legal residents of British Columbia who have reached nineteen (19) years of age at the time of entry and otherwise comply with these Official Contest Rules (the "Contest Rules"). Anyone who carries out any of the above using an Instagram account and complies with the Contest Rules will be entered for a chance to win. All Contest entries must be received by the end of the Contest Period. ## 5. WINNER SELECTION:

Random draws will be conducted according to the following schedule for all prizes by BC Hydro to select one (1) entrant from all eligible Contest entries from @bchydro on Instagram and (1) entrant from all eligible Contest entries from BC Hydro's Facebook to each win the prize.

The chances of winning depend on the total number of eligible entries received.
