

**BC HYDRO FALL GUIDE CONTEST
OFFICIAL CONTEST RULES
NO PURCHASE REQUIRED**

1. CONTEST PERIOD:

British Columbia Hydro and Power Authority ("BC Hydro") **BC HYDRO FALL GUIDE CONTEST** (the "Contest") begins on September 4 2026 at 8:00 a.m. Pacific Time ("PT") and ends on September 27, 2026 at 11:59 p.m. PT (the "Contest Period").

2. ELIGIBILITY:

NO PURCHASE REQUIRED. The Contest is open to all legal residents of British Columbia who have reached nineteen (19) years of age at the time of entry and otherwise comply with these Official Contest Rules (the "Rules"). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

3. HOW TO ENTER:

NO PURCHASE REQUIRED. There are three ways to enter the contest. To enter for a chance to win complete the following steps during the Contest Period:

1. Visit facebook.com/bchydro during the contest period
2. Look for the contest post shared on September 4, 2026
3. The post will ask that viewers (1) like the post (2) reply to the prompt in the comments
4. Multiple comments from individual viewers are allowed and will count as separate entries.

OR

1. Visit instagram.com/bchydro during the contest period.
2. Look for contest posts shared on September 4, 2026
3. The post will ask that viewers (1) tag a friend in the comments (2) like the post; and (3) follow [@bchydro](https://instagram.com/bchydro) on Instagram.
4. Share the post on Instagram stories and tag [@bchydro](https://instagram.com/bchydro) for three bonus entries
5. Multiple comments from individual viewers are allowed and will count as separate entries.

Anyone who carries out the steps described above and complies with these Contest Rules including but not limited to the eligibility requirements will be entered for a chance to win. All Contest entries must be received by the end of the Contest Period. BC Hydro is not responsible for and accepts no liability for late, lost, misdirected, delayed, or incomplete entries.

5. WINNER SELECTION:

A random draw will be conducted on September 28, 2026 by BC Hydro to select 1 entrants from all eligible Contest entries from the BC Hydro Instagram account (@BCHYDRO), select 1 entrants from all eligible Contest entries from the BC Hydro Facebook account (BC Hydro) and select 1 entrants from all eligible Contest entries from the Connected news article, to win a prize package. The chances of winning depend on the total number of eligible entries received.

Before being declared a winner, the selected entrants will be contacted via their social media account and be required to send their name, address, email and phone number. Once contact information is provided, BC Hydro will contact the selected entrant who will be required to, (a) correctly answer a mathematical skill-testing question and (b) sign and return a Declaration, Consent and Release form in order to receive the prize. At least two (2) attempts will be made over the two (2) days following the draw to contact the selected entrant. If a selected entrant cannot be contacted, fails to correctly answer the skill-testing question, fails to complete and return the Declaration, Consent and Release form within the five (5) business days after being contacted, or cannot accept the prize for any reason, then at BC Hydro's sole discretion, that entrant will be disqualified and another entrant will be selected by random draw from remaining eligible entries. 7. PRIVACY:

BC Hydro will use any personal information provided with the entry, including the entrants' name, address, postal code, email, and phone number for the purpose of administering the Contest, as contemplated by these Rules. BC Hydro collects and uses personal information and runs this Contest in furtherance of its conservation mandate under the Hydro and Power Authority Act and Clean Energy Act and in accordance with the provisions of the Freedom of Information and Protection of Privacy Act.

GENERAL CONDITIONS:

By entering the Contest, entrants accept and agree to be bound by these Rules and the decisions of BC Hydro, which shall be final and legally binding. No correspondence will be entered into by BC Hydro with respect to the Contest except with selected entrants. BC Hydro reserves the right to terminate or amend this Contest at any time without prior notice. The Contest is subject to the laws of the Province of British Columbia and all applicable federal and municipal laws. The sole jurisdiction to resolve any disputes concerning this Contest is the Province of British Columbia

8. DISQUALIFICATION:

BC Hydro reserves the immediate right to disqualify any entrant which it deems, in its sole discretion, (i) is not in compliance with these Rules, (ii) tampers with the entry process, the Contest, or the website; or (iii) is acting in an uncooperative, unsportsmanlike, disruptive, abusive, or threatening manner.
