

**BC HYDRO HOLIDAY COUNTDOWN CONTEST
OFFICIAL CONTEST RULES
NO PURCHASE REQUIRED**

1. CONTEST PERIOD:

British Columbia Hydro and Power Authority (“**BC Hydro**”) Holiday Countdown Contest (the “**Contest**”) begins on December 1, 2021 at 12:00 a.m. Pacific Time (“**PT**”) and ends on December 31 at 11:59 p.m. PT (the “**Contest Period**”).

2. ELIGIBILITY:

The Contest is open to all residents of British Columbia who have reached the age of nineteen (19) years at the time of entry and otherwise comply with these Official Contest Rules (the “**Contest Rules**”). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

3. HOW TO ENTER:

NO PURCHASE REQUIRED. To enter for a chance to win, complete the following steps during the Contest Period:

- (a) Visit holidays.bchydro.com during the Contest Period.
- (b) Click on the day and you will be prompted to interact with a piece of content. You could be asked to read an article, participate in a quiz or vote in a poll.
- (c) You are then prompted to submit the Contest entry form by providing the following information: first and last name and email address.

Anyone who carries out the steps described above and complies with these Contest Rules including but not limited to the eligibility requirements will be entered for a chance to win. BC Hydro will make at least 3 attempts over the 10 days following the draw to contact the selected entrant. If the selected entrant cannot be contacted, fails to correctly answer the mathematical skill-testing question, fails to complete and return the Declaration, Consent, and Release form within 5 business days after being contacted, or cannot accept the prize for any reason, then at BC Hydro’s sole discretion, that selected entrant will be disqualified and another entrant will be selected by random draw from remaining eligible entries.
