

# BC HYDRO HOLIDAY COUNTDOWN CONTEST OFFICIAL CONTEST RULES NO PURCHASE REQUIRED

### 1. CONTEST PERIOD:

British Columbia Hydro and Power Authority ("**BC Hydro**") Holiday Countdown Contest (the "**Contest**") begins on December 1, 2023 at 12:00 a.m. Pacific Time ("PT") and ends on December 31, 2023 at 11:59 p.m. PT (the "**Contest Period**").

### 2. ELIGIBILITY:

The Contest is open to all residents of British Columbia who have reached the age of nineteen (19) years at the time of entry and otherwise comply with these Official Contest Rules (the "**Contest Rules**"). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

### 3. HOW TO ENTER:

NO PURCHASE REQUIRED. To enter for a chance to win, complete the following steps during the Contest Period:

- (a) Visit holidays.bchydro.com during the Contest Period.
- (b) Click on the day and you will be prompted to interact with a piece of content. You could be asked to read an article, participate in a quiz or vote in a poll.
