# OFFICIAL CONTEST RULES NO PURCHASE REQUIRED

#### 1. CONTEST PERIOD:

British Columbia Hydro and Power Authority ("BC Hydro") "Keep Cool" Contest (the "Contest Rules") begins on July 4, 2023 at 8:00 a.m. Pacific Time ("PT") and ends on July 23, 2023 at 11:59 p.m. PT (the "Contest Period").

#### 2. ELIGIBILITY:

NO PURCHASE REQUIRED.
