OFFICIAL CONTEST RULES
NO PURCHASE REQUIRED

1. CONTEST PERIOD:

British Columbia Hydro and Power Authority (“**BC Hydro**”) Power Smart Shop (the “**Contest**”) begins on March 3, 2026 at 10:00 a.m. Pacific Time (“**PT**”) and ends on March 31, 2026 at 11:59 p.m. PT (the “**Contest Period**”).

2. ELIGIBILITY:

The Contest is open to all residents of British Columbia who have reached the age of nineteen (19) years at the time of entry and otherwise comply with these Official Contest Rules (the “**Contest Rules**”).
