

**POWERED IN B.C. INSTAGRAM OFFICIAL CONTEST RULES
NO PURCHASE REQUIRED**

1. CONTEST PERIOD:

British Columbia Hydro and Power Authority (“**BC Hydro**”) Powered in B.C. Contest (the “**Contest**”) begins on July 1, 2025 at 12:00 a.m. Pacific Time (“PT”) and ends on August 31, 2025 at 11:59 p.m. PT (the “**Contest Period**”).

2. ELIGIBILITY:

The Contest is open to all residents of British Columbia who have reached the age of nineteen (19) years at the time of entry and otherwise comply with these Official Contest Rules (the “**Contest Rules**”). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

6. WINNER NOTIFICATION:

Before being declared a winner, BC Hydro will contact the selected entrant via the social media platform used by that selected entrant to submit a Contest entry and request the selected entrant to contact BC Hydro to provide contact information within 48 hours of BC Hydro's request. Once contact information is provided and BC Hydro has contacted the selected entrant by phone or email, the selected entrant is required to (a) correctly answer a time-limited mathematical skill-testing question without mechanical or other assistance and (b) sign and return a Declaration, Consent, and Release form which confirms compliance with these Contest Rules, acknowledges acceptance of the prize as awarded, and releases BC Hydro from any and all liability in connection with this Contest and the prize.
