

BC HYDRO SUMMER OF SAVING SOCIAL MEDIA CONTEST
OFFICIAL CONTEST RULES
NO PURCHASE REQUIRED

1. CONTEST PERIOD:

British Columbia Hydro and Power Authority (“**BC Hydro**”) Summer of saving Social Media Contest (the “**Contest**”) begins on July 8, 2024 at 12:00 a.m. Pacific Time (“PT”) and ends on August 11, 2024 at 11:59 p.m. PT (the “**Contest Period**”).

2. ELIGIBILITY:

The Contest is open to all residents of British Columbia who have reached the age of nineteen (19) years at the time of entry and otherwise comply with these Official Contest Rules (the “**Contest Rules**”). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.
