

## BC HYDRO “SPRING INTO SUMMER ADVENTURE” CONTEST

### OFFICIAL CONTEST RULES NO PURCHASE REQUIRED

#### 1. CONTEST PERIOD:

British Columbia Hydro and Power Authority (“BC Hydro”) “spring into summer adventure contest” (the “Contest Rules”) begins on May 15th, 2019 at 8:00 a.m. Pacific Time (“PT”) and ends on May 23rd, 2019 at 11:59 p.m. PT (the “Contest Period”).

#### 2. ELIGIBILITY:

NO PURCHASE REQUIRED. The Contest is open to all legal residents of British Columbia who have reached nineteen (19) years of age at the time of entry and otherwise comply with these Official Contest Rules (the “Contest Rules”). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

#### 3. HOW TO ENTER:

NO PURCHASE REQUIRED. To enter for a chance to win, complete one (1) of the following steps during the Contest Period:

- (a) on May 15<sup>th</sup>, 2019 @bchydro on Instagram will post content about outdoor summer adventures requesting that viewers (1) like the post; (2) follow @bchydro on Instagram; and (3) tag their camping buddy in the comments

- (b) on May 15<sup>th</sup>, 2019 @bchydro on Twitter will post content about outdoor summer adventures requesting that viewers (1) like the content and (2) follow @bchydro on Twitter;

OR

- (c) on May 15<sup>th</sup>, the BC Hydro Facebook page will post content about outdoor summer adventures requesting that viewers (1) like the content and (2) comment your favourite camping spot on the post.

#### **5. WINNER SELECTION:**

A random draw will be conducted on May 24<sup>th</sup>, 2019 by BC Hydro to select three (3) entrants, one (1) entrant from all eligible Contest entries from @bchydro on Instagram, one (1) entrant from all eligible Contest entries from @bchydro on Twitter, and one (1) entrant from all eligible Contest entries from the BC Hydro Facebook page to each win the prize. If the same winner is selected for any of social media platforms, BC Hydro will redraw for @bchydro on Twitter. If a second redraw is necessary, BC Hydro will redraw from the BC Hydro Facebook page. The chances of winning depend on the total number of eligible entries received.

Before being declared a winner, the selected entrants will be contacted via their social media account and be required to send their name, address, email and phone number. Once contact information is provided, BC Hydro will contact the selected entrant who will be required to, (a) correctly answer a mathematical skill-testing question and (b) sign and return a Declaration, Consent and Release form in order to receive the prize. At least two (2) attempts will be made over the two (2) days following the draw to contact the selected entrant. If a selected entrant cannot be contacted, fails to correctly answer the skill-testing question, fails to complete and return the Declaration, Consent and Release form within the five (5) business days after being contacted, or cannot accept the prize for any reason, then at BC Hydro's sole discretion, that entrant will be disqualified and another entrant will be selected by random draw from remaining eligible entries.
