

BC HYDRO SUMMER STARTER PACK CONTEST

OFFICIAL CONTEST RULES

1. CONTEST PERIOD:

British Columbia Hydro and Power Authority (“BC Hydro”) **BC HYDRO SUMMER STARTER PACK CONTEST** (the “Contest”) begins on June 1, 2026 at 8:00 a.m. Pacific Time (“PT”) and ends on June 30, 2026 at 11:59 p.m. PT (the “Contest Period”).

2. ELIGIBILITY:

NO PURCHASE REQUIRED. The Contest is open to all legal residents of British Columbia who have reached nineteen (19) years of age at the time of entry and otherwise comply with these Official Contest Rules (the “Rules”). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

3. HOW TO ENTER:

To enter for a chance to win 1 x **Hisense Portable Air Conditioner** (valued at \$748), 1 x **Dyson Hushjet Air Purifier-White** (valued at \$440) and 1 x **Napoleon Portable Electric BBQ Grill** – (valued at \$399), complete the following steps during the Contest Period:

All Contest entries must be received by the end of the Contest Period. All entries become the property of BC Hydro and will be stored and destroyed in compliance with the Freedom of Information and Protection of Privacy Act. BC Hydro is not responsible for and accepts no liability for late, lost, misdirected, delayed, or incomplete entries.

Limit one entry per person. Any person who enters more than the allowable number of entries into the Contest using multiple user names or identities will be disqualified by BC Hydro, in its sole discretion.

4. PRIZES:

There is one prize package available to win:

1 x Hisense 10,000 BTU SACC Portable Air Conditioner (AP10TW1RLR-N) – approx. \$748.00 CAD

1 x Dyson Hushjet Air Purifier-White (HJ10WHITE) – approx. \$439.99 CAD

1 x Napoleon TravelQ PRO285E Portable Electric BBQ Grill - approx. \$399.00 CAD

The value of the prize package is approximately \$1589.99 CAD.

Prizes are not transferable and must be accepted as awarded with no substitutions in cash or otherwise. BC Hydro reserves the right, in the event that any prize or any component of a prize cannot be awarded as described for any reason, to substitute another prize or component of a prize of equal or greater value, without liability. LIMIT one (1) prize per person per household. Prizes are subject to any terms, conditions, and restrictions imposed by their issuer or manufacturer.

5. WINNER SELECTION:

A random draw will be conducted on July 2, 2026 by BC Hydro to select 1 entrants from all eligible Contest entries from Connected newsletter to win a prize package. The chances of winning depend on the total number of eligible entries received.

Before being declared a winner, the selected entrants will be contacted via their social media account and be required to send their name, address, email and phone number. Once contact information is provided, BC Hydro will contact the selected entrant who will be required to, (a) correctly answer a mathematical skill-testing question and (b) sign and return a Declaration, Consent and Release form in order to receive the prize. At least two (2) attempts will be made over the two (2) days following the draw to contact the selected entrant. If a selected entrant cannot be contacted, fails to correctly answer the skill-testing question, fails to complete and return the Declaration, Consent and Release form within the five (5) business days after being contacted, or cannot accept the prize for any reason, then at BC Hydro's sole discretion, that entrant will be disqualified and another entrant will be selected by random draw from remaining eligible entries. By accepting the prize, the winners consent to the use of their names, including Facebook user names, photograph or other likenesses for any publicity purpose connected with this Contest without further compensation, within or outside of Canada.

6. CONSENT:

Once submitted, entries cannot be modified, deleted or cancelled by a Contest entrant.

BC Hydro will use any personal information provided with the entry, including the entrants' name, address, postal code, email, and phone number for the purpose of administering the Contest, as

contemplated by these Rules. BC Hydro collects and uses personal information and runs this Contest in furtherance of its conservation mandate under the Hydro and Power Authority Act and Clean Energy Act and in accordance with the provisions of the Freedom of Information and Protection of Privacy Act.

8. GENERAL CONDITIONS:

By entering the Contest, entrants accept and agree to be bound by these Rules and the decisions of BC Hydro, which shall be final and legally binding. No correspondence will be entered into by BC Hydro with respect to the Contest except with selected entrants. BC Hydro reserves the right to terminate or amend this Contest at any time without prior notice. The Contest is subject to the laws of the Province of British Columbia and all applicable federal and municipal laws. The sole jurisdiction to resolve any disputes concerning this Contest is the Province of British Columbia

9. DISQUALIFICATION:

BC Hydro reserves the immediate right to disqualify any entrant which it deems, in its sole discretion, (i) is not in compliance with these Rules, (ii) tampers with the entry process, the Contest, or the website; or (iii) is acting in an uncooperative, unsportsmanlike, disruptive, abusive, or threatening manner.
