POWER SMART PROGRAM OVERVIEW FOR THE LIGHTING INDUSTRY

If your customers want to cut electricity costs and reduce energy use, BC Hydro Power Smart has programs available for them. From small and medium commercial customers to large industrial sites, there is a program that is designed to meet their needs.

The table below describes the three main Power Smart programs for lighting projects. There are specific criteria that determine which program your customers are eligible for. If you are unsure, please use Power Smart Business Program Eligibility Tool to determine the eligibility of your customer's site. The customer's 11-digit account number will be needed to enter to determine the program that best suits your customers' needs.
