

BC HYDRO EV CAMPAIGN FALL 2019 CONTEST OFFICIAL CONTEST RULES NO PURCHASE REQUIRED

1. CONTEST PERIOD:

British Columbia Hydro and Power Authority ("BC Hydro") EV Campaign Fall 2019 Contest (the "Contest") begins on September 30, 2019 at 12:00 a.m. Pacific Time ("PT") and ends on November 10, 2019 at 11:59 p.m. PT (the "Contest Period").

2. ELIGIBILITY:

The Contest is open to all residents of British Columbia who have reached the age of nineteen (19) years at the time of entry and otherwise comply with these Official Contest Rules (the "Contest Rules"). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

3. HOW TO ENTER:

NO PURCHASE REQUIRED. To enter for a chance to win, complete the following steps during the Contest Period:

- (a) Visit www.bchydro.com/ev during the Contest Period.
- (b) Click on the contest promotion tile and you will be prompted to answer a knowledge-based question about electric vehicles. The question is multiple choice and all answers are accepted. You will also be asked an optional, opinion-based question about electric vehicles.
- (c) You are then prompted to submit the Contest entry form by providing the following information: first and last name, email, phone number, city of residence and agreeing to these terms and conditions. *Note: winner's first name, initial and city of residence will be shared on BC Hydro's website and social media platforms.

Anyone who carries out the steps described above and complies with these Contest Rules including but not limited to the eligibility requirements will be entered for a chance to win. All Contest entries must be received by the end of the Contest Period. BC Hydro is not responsible for and accepts no liability for late, lost, misdirected, delayed, or incomplete entries.

LIMIT ONE (1) ENTRY PER PERSON PER WEEK, which will be eligible for the Weekly Prize draw for that week and for the Grand Prize draw.
