For the Contractor and Participant:

The CleanBC Go Electric Home and Workplace Charging Program (the “**Program**”) provides rebates for single family homes, multi-unit residential buildings (MURBs), and workplaces to purchase and install eligible level 2 electric vehicle (EV) chargers and for MURBs to develop and implement EV Ready plans. Funded by the Province of British Columbia (the “**Province**”) and administered by British Columbia Hydro and Power Authority (“**BC Hydro**”) and FortisBC Energy Inc. (“**FortisBC**” and collectively with BC Hydro and the Province, the “**Administrators**”), the Program aims to encourage and accelerate the adoption of EVs, make EV ownership and charging more affordable, improve access to EV chargers, encourage the use of more energy efficient technologies, improve air quality, and reduce greenhouse gas emissions from vehicles.

As the electrical contracting or electrical engineering company (the “**Contractor**”) retained by an applicant of the Program (the “**Participant**”) to prepare an EV Ready Plan, undertake EV Ready electrical infrastructure upgrades and/or carry out the installation of an EV charger, you, the Contractor, are receiving this form because the Participant is seeking your assistance in preparing and submitting required documentation needed to qualify for rebate offers under the Program. The signing authority for the Participant, and the signing authority for the Contractor, must complete this form in full and sign the declaration, which will provide consent to the Contractor to submit required documentation to the Administrators on behalf of the Participant.

Important notes:

- The Participant (not the Contractor) must apply to the rebate and be the rebate payment recipient.
- For the Participant to be eligible and receive payment for Program rebate offers, all project work completed by the Contractor must meet or exceed the required criteria in the Participant Rebate Eligibility Requirements (the “**Program Guide**”) and the Participant Terms and Conditions (“**Terms and Conditions**”), which are both available at goelectricbc.gov.bc.ca, bchydro.com/evcharger, and fortisbc.com/EV.
- The signing authority for the Contractor must complete section 1 on page 2 of this form and sign the declaration and consent form on page 3 and return it to the Participant.
- The Participant must complete sections 2 and 3 on page 2 of this form and the Participant must have a minimum of one signing authority sign and date the declaration and consent form on page 3. A copy of the fully completed and signed form must be submitted to the relevant Administrator and shared with the Contractor.
- Once the Administrator provides an email confirmation of pre-approval for the rebate application, the Contractor is authorized to submit project documentation of the Participant.

I/we acknowledge that the removal process may require up to five business days and that the Administrators assume no liability or responsibility for any delays or for any matter arising from the permission granted above.
- I/we have read and understood the eligibility requirements for the EV Ready plan rebate, the EV Ready infrastructure rebate and/or the MURB Charger Rebate as described in the Program Guide and in the Terms and Conditions documents. I/we acknowledge that a failure to meet eligibility requirements will result in an application getting rejected.
- I/we acknowledge that it is the responsibility of the Strata Corporation, Co-op Board or Landlord of the property to work in good faith with the Contractor to ensure that the work completed by the Contractor and the required documentation meets or exceeds the required criteria specified in the Program Guide.
- I/we acknowledge that the Participant is assigning responsibility to the Contractor to submit all required documentation for final approval on behalf of the Participant before the deadlines stated in the Program Guide document. If an extension is needed, the Contractor or the Participant will need to submit a written extension request to the relevant Administrator before the applicable deadline. However, submitting a request does not guarantee that an extension will be approved.
- I/we understand that the rebate offer is subject to the availability of funds and eligibility in accordance with the requirements and terms of the Program.
- The information contained in this Contractor Participant Consent Form is true and complete. I/we understand that any willful misstatements may cause the rejection of this application.
- I/we consent to the Administrators (The Province, BC Hydro and FortisBC) collecting and relying on the information submitted on this form. I/we acknowledge that the Administrators may contact me to verify the information submitted on this form or for the purposes of administering, implementing, or evaluating the Program.
