

**BC Hydro and Power Authority (BC Hydro)**  
**PEAK REWARDS PROGRAM (the Program)**

**Program Terms and Conditions**

1. For the purposes of this Agreement, the following terms have the following meaning:
  - **You or Your** are references to the Participant as identified in the Application.
  - **Reward** means either an actual payment, or an offset against the amount owed by you to BC Hydro for electricity. If you receive an offset, the offset is a mechanism for providing you with a reward for your Program participation and is not a deduction of, variance from, or waiver of, the amounts owed you for electricity provided to you by BC Hydro.
  - **Summer Season** means from May 1, 2020 to Sept 30, 2020.
  - **Winter Season** means from October 1, 2020 to March 31, 2021.
2. For purposes of the Program BC Hydro may at its sole discretion and in consideration of existing conditions and safety, determine if the Equipment has been installed in your Residence.
3. You represent and warrant that:
  - a. You are an individual 19 years or older;
  - b. You are the BC Hydro residential account holder for the Residence and an owner of the Residence;
4. You agree that BC Hydro and/or BC Hydro's representatives or contractors may remotely control the Equipment in your Residence during the "**Program Term**" (which is defined as May 1, 2020 to March 31, 2021, inclusive). Any remote controlling action taken by BC Hydro and/or BC Hydro's representatives or contractors will be referred to herein as a "**Control Event**".
5. You agree that:
  - a. BC Hydro and/or BC Hydro's representatives or contractors may enact a Control Event at any time of day or night;
  - b. There may be multiple Control Events enacted in a single day.
6. You acknowledge and agree that the Equipment uses various wireless communication technologies to collect and exchange data between the Equipment and central data servers and applications.
7. You agree to allow BC Hydro to collect data from during the Program Term and to access your Residence historical smart meter energy data for the two years immediately preceding your enrollment in the Program for analysis purposes.
8. You may opt-out of any Control Event, at any time, via the web interface or mobile app provided by the Equipment manufacturers.

9. You agree to maintain the Equipment in good working order throughout the Program Term.
10. You acknowledge and agree that no person or entity except the manufacturers, BC Hydro or BC Hydro representatives shall have the right to control or dispatch the Equipment and exercise load control during the Program Term and you further agree not to authorize anyone else to control the Equipment during the Program Term.
11. This Agreement shall be in effect until the end of the Program Term, unless otherwise terminated by you or BC Hydro.
12. You may terminate this Agreement by providing at least 5 days written notice to BC Hydro. In the event you terminate this Agreement, BC Hydro will cease to adjust the operation of the Equipment as of the termination date.
13. BC Hydro may terminate this Agreement at any time for any reason without notice.
14. You agree to participate in up to two follow up surveys or audits conducted by BC Hydro or its representatives in connection with the Program during the Program Term and at any point up to July 31, 2021. This section shall survive expiration or early termination of this Agreement.
15. You acknowledge and agree that:
  - a. you have independently assessed the risk of remote controlling the Equipment and you accept such risk;
  - b. BC Hydro makes no representation or warranty, express, implied, statutory or otherwise, including any representation or warranty as to merchantability, design, capabilities, suitability, durability or fitness for use or for a particular purpose, with regard to the Equipment, its installation, or any part thereof;
  - c. BC Hydro is not liable for any impacts, damage or destruction to your Residence, the Equipment, the EV battery life, or driver usage of the EV as a result of the use or operation of the Equipment under the terms of this Agreement, or otherwise as a result of your participation in the Program.
16. You acknowledge and agree that:
  - a. BC Hydro does not guarantee any energy cost savings or other benefits arising from your participation in the Program; and
  - b. BC Hydro, its respective successors, representatives, assignors, affiliates, employees, agents, officers, directors, service providers, contractors (including any Installers) and their respective affiliates, officers, directors or employees and any of their heirs, successors or assigns (collectively, the “**Program Operators**”) are not and will not be liable for any loss, damage or injury (including death) to persons or property, including without limitation any direct, indirect, special or consequential damages (including but not limited to loss of profit, loss of revenues or other economic loss), and any costs or losses, expenses, fees, liabilities, causes of action, suits, proceedings, debts, penalties and demands connected with or in any way arising from the installation or use of the Equipment, the interruption of power to the Equipment, the Program or any matter related to this Agreement, including, without limitation, any acts or omissions of any Program Operator and you hereby release the Program

Operators of, from and against any and all of the foregoing. You agree to indemnify the Program Operators if you or any member of your family, occupant or guest seeks damages against any of them for any reason that is connected with this Agreement or the Equipment. The maximum liability of the Program Operators for any matter, claim or damage in connection with this Agreement and the Equipment is limited to \$1,000.

17. You understand that any personal information provided to BC Hydro is collected, used, and disclosed in accordance with British Columbia's *Freedom of Information and Protection of Privacy Act*, as amended from time to time. BC Hydro collects personal information further to its mandate under the *Hydro and Power Authority Act* and, with regard to conservation activities, under the *Clean Energy Act*, and related Regulations and Directions, as amended from time to time.
18. You consent to the indirect collection, use, disclosure and other handling of any information provided by you to the Program Operators, including but not limited to personal information such as your name, address, telephone number, email address, device identification numbers, and records showing distance driven, state of charge, energy consumption and charging patterns (collectively the foregoing is referred to as "**Program Participant Information**") to the Program Operators for the purposes of administering and assessing the Program, and any other disclosure or reporting that may be required by law. You acknowledge that certain BC Hydro contractors involved in the Program may be based or otherwise have operations outside of Canada, and you therefore consent to your personal information being stored or accessed from outside Canada. If you have any questions about how BC Hydro handles or uses personal information, you may contact a Customer Service representative at 1-800-224-9376.
19. BC Hydro shall not be in default, and shall not be deemed to be in default, by reason of delay or the failure or inability to perform its obligations under this Agreement where the said delay, failure or inability is due solely to any cause which is unavoidable or beyond the reasonable control of BC Hydro, including without limitation any act of God or other cause which frustrates the performance of this Agreement.
20. You will not assign this Agreement.
21. This Agreement shall be interpreted in accordance with the laws of the Province of British Columbia.
22. This Agreement may be amended by BC Hydro upon thirty 30 days written notice.
23. BC Hydro reserves the right, in its sole discretion, to reject, accept or revise any Application made to it under the Program and to elect not to be bound by this Agreement.
24. BC Hydro may terminate the Program at any time.
25. Terms 14, 15, 16, 17, 18, and 21, and any terms and conditions required for their interpretation, shall survive expiration or earlier termination of this Agreement.
