BRITISH COLUMBIA HYDRO AND POWER AUTHORITY ("BC HYDRO") 2015 POWER SMART FORUM CONTEST RULES

1. How to Enter and Eligibility

No purchase required. All registered attendees at the 2015 Power Smart Forum (to be held at Vancouver Convention Centre on October 27, 2015) who have reached the age of majority in their jurisdiction of residence at the time of registration will be automatically entered into the two contests referred to below (the "Contests") provided they meet the corresponding eligibility requirements ('Eligible Registrants"). 2. Prizes, Draws and Chances of Winning

- a. Early Bird Draw: There is one (1) Early-bird prize available to be won, consisting of one Canon EOS Rebel camera and photo finishing package at London Drugs, approximate retail value of \$1000 CDN. A random draw will be conducted by BC Hydro or its representatives on or around September 15, 2015 to select one (1) entry from all Eligible Registrants. The chances of winning are dependent upon the total number of individuals that register for the Power Smart Forum by the Early Bird deadline.
