A photo of either the Earth Day puppet show or Our green future activity must be submitted to schools@bchydro.com by April 23, 2021 for the chance to win. Limit of one contest entry per person. All contest entries will be collected by BC Hydro and a random draw to determine the winning contest entrant will take place on or around April 26, 2021. All entries will become the property of BC Hydro. All eligible entries may be posted for public viewing on the Power Smart for Schools website, bchydro.com, and/or @bchydro social media channels, subject to BC Hydro confirming their eligibility in accordance with the Contest terms and conditions.
- 3) **Prize.** There is one classroom prize to be won. The prize is a package of pencil pouches, pens, water bottles, seed boxes, plant seeds, notebook, re-usable straw, and utensil set.
