## Utility Account Holder Consent Form

### Important notes

- Energy-efficiency upgrades are planned to be made to a home serviced by a utility account in your name. Pre-approval for these upgrades must be received from British Columbia Hydro and Power Authority ("BC Hydro") prior to purchase and installation of any energy efficient technologies. The home's registered property owner, Strata Corporation or Equity Co-Op Board (the "Applicant") intends to apply for the Condo and Apartment Rebate Program (the "Program"). The Program is administered by BC Hydro.
- To administer the Program, evaluate the effectiveness of the Program, and undertake analysis and research to inform changes to existing programs and the design of new energy-efficiency programs, BC Hydro may need to collect, use and disclose your personal information, including your electricity and/or natural gas account(s) billing and consumption data. The purpose of this form is to acquire your declaration and consent to the collection, use and disclosure of your personal information ("Consent Form").
- This Consent Form is to be completed by the primary electric utility account holder(s) or authorized signatory where the utility account is not in the Applicant's name.

- To be contacted by BC Hydro (or their authorized agents) by phone, direct mail or similar method for the purposes of administering, evaluating and researching all elements of the Program.
