

BC HYDRO FALL CONSERVATION CAMPAIGN CONTEST
OFFICIAL CONTEST RULES
NO PURCHASE REQUIRED

1. CONTEST PERIOD:

British Columbia Hydro and Power Authority (“**BC Hydro**”) Fall Conservation Campaign 2021 Contest (the “**Contest**”) begins on September 29, 2021 at 12:00 AM Pacific Time (“PT”) and ends on November 14, 2021 at 11:59 PM PT (the “**Contest Period**”).

2. ELIGIBILITY:

The Contest is open to all residents of British Columbia who have reached the age of nineteen (19) years at the time of entry and otherwise comply with these Official Contest Rules (the “**Contest Rules**”). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

3. HOW TO ENTER:

NO PURCHASE REQUIRED. To enter for a chance to win, complete the following steps during the Contest Period:

- (a) Visit www.powersmart.ca during the Contest Period.
- (b) Navigate to the contest overview page, then click **Enter the contest**.
- (c) Submit your answer to our weekly contest question
- (d) Fill out and submit the Contest entry form by providing the following information: first and last name, email and phone number, and agreeing to these terms and conditions.
**Note: winner’s first name, last name initial and city of residence may be shared on BC Hydro’s website and social media platforms.*

Anyone who carries out the steps described above and complies with these Contest Rules including but not limited to the eligibility requirements will be entered for a chance to win. All Contest entries must be received by the end of the Contest Period. BC Hydro is not responsible for and accepts no liability for late, lost, misdirected, delayed, or incomplete entries.

LIMIT ONE (1) ENTRY PER PERSON PER WEEK, which will be eligible for the Weekly Prize draw for that week and for the Grand Prize draw. The maximum number of entries a person can submit for the Grand Prize draw is seven (7), one for each week during the Contest Period. Any person who enters more than the allowable number of entries into the Contest and/or uses multiple names or identities will be disqualified by BC Hydro.

BC Hydro will make at least 3 attempts over the 10 days following the draw to contact the selected entrant.
