

BOOST YOUR POWER SMARTS CONTEST OFFICIAL CONTEST RULES

1. CONTEST PERIOD:

The British Columbia Hydro and Power Authority (“BC Hydro”) Boost your Power Smarts Contest (the “Contest”) begins on October 1, 2018 at 12:00 a.m. Pacific Time (“PT”) and ends on November 12, 2018 at 9:00 a.m. PT (the “Contest Period”).

2. ELIGIBILITY:

NO PURCHASE REQUIRED. The Contest is open to all legal residents of British Columbia who have reached nineteen (19) years of age at the time of entry and otherwise comply with these Official Contest Rules (the “Contest Rules”). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

3. HOW TO ENTER:

To enter for a chance to win the Grand Prize and Weekly Prizes, visit www.powersmart.ca during the Contest Period. Click on the Contest promotion tile and complete and submit the Contest entry form by providing the following information: first & last name, email, phone number, and agreeing to these terms and conditions. The submitted entry will be entered into the random draws for the Grand Prize and the Weekly Prizes. All Contest entry forms must be received by the end of the Contest Period. All entries become the property of BC Hydro and will be stored and destroyed in compliance with the *Freedom of Information and Protection of Privacy Act*. BC Hydro is not responsible for and accepts no liability for late, lost, misdirected, delayed, or incomplete entries.

Limit one (1) entry per person per week, which will be eligible for the Weekly Prize draw for that week and for the Grand Prize draw. The maximum number of entries a person can submit for the Grand Prize draw is six (6), one for each week during the Contest Period. Any person who enters more than the allowable number of entries into the Contest and/or use multiple names or identities to enter the Contest will be disqualified.

5. WINNER SELECTION:

Weekly Prizes: Weekly Prize draws will be conducted each week by BC Hydro to select one (1) entrant for each week of the Contest Period, from all eligible Contest entries submitted by entrants during that respective week prior to the draw date to win the Weekly Prize (a “Weekly Prize Selected Entrant”), on the dates as follows:

The chances of winning a Weekly Prize depend on the total number of eligible entries received during that week of the Contest Period. Winners of the Weekly Prizes will also be eligible to win the Grand Prize.

Grand Prize: A random draw will be conducted on or around November 28, 2018 by BC Hydro to select one (1) entrant from all eligible Contest entries to win the Grand Prize (the “Grand Prize Selected Entrant”). The chances of winning the Grand Prize depend on the total number of eligible entries received during the Contest Period.

Before being declared a winner, the Weekly Prize Selected Entrant and Grand Prize Selected Entrant will be contacted by phone or email and be required to (a) correctly answer a mathematical skill-testing question and (b) sign and return the Declaration and Release form which confirms compliance with these Contest Rules, acknowledges acceptance of the prize as awarded, and releases BC Hydro from any and all liability in connection with this Contest and the prize. At least three (3) attempts will be made over the ten (10) days following the draw to contact the Weekly Prize Selected Entrant and the Grand Prize Selected Entrant. If a selected entrant cannot be contacted, fails to correctly answer the skill-testing question, fails to complete and return the Declaration and Release Form within five (5) business days, or cannot accept the prize for any reason, then at BC Hydro’s sole discretion that person will be disqualified and another entrant will be selected by random draw from remaining eligible entries. BC Hydro is not responsible for the failure for any reason whatsoever, including its own negligence or due to computer, telephone or technical problems, of a selected entrant to receive notification or for BC Hydro to receive a response from a selected entrant. In the event of a dispute regarding identity of the selected entrant, the entry will be deemed submitted by the holder of the associated email account.

BC Hydro will use any personal information provided with the entry, including the entrants’ name, address, postal code, email, and phone number for the purpose of administering the Contest and for BC Hydro’s marketing and promotional purposes, both inside and outside of Canada, as contemplated by these Contest Rules. BC Hydro collects and uses personal information and runs this Contest in furtherance of its conservation mandate under the *Clean Energy Act* and in accordance with the provisions of the *Freedom of Information and Protection of Privacy Act*. BC Hydro reserves the right to terminate or amend this Contest at any time without prior notice. BC Hydro reserves the immediate right to disqualify

any entry that it deems, in its sole discretion: (i) is not in compliance with these Contest Rules, or (ii) tampers with this Contest in any way. This Contest is subject to the laws of the Province of British Columbia and all applicable federal and municipal laws. The sole jurisdiction to resolve any disputes concerning this Contest is the Province of British Columbia.
