

# BC HYDRO BOOST YOUR POWER SMARTS SPRING 2019 CONTEST OFFICIAL CONTEST RULES NO PURCHASE REQUIRED

#### 1. CONTEST PERIOD:

British Columbia Hydro and Power Authority ("**BC Hydro**") Boost your Power Smarts Spring 2019 Contest (the "**Contest**") begins on March 4, 2019 at 12:00 a.m. Pacific Time ("PT") and ends on April 14, 2019 at 11:59 [a.m./p.m.] PT (the "**Contest Period**").

#### 2. ELIGIBILITY:

The Contest is open to all residents of British Columbia who have reached the age of nineteen (19) years at the time of entry and otherwise comply with these Official Contest Rules (the "**Contest Rules**"). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

- (b) Click on the contest promotion tile and you will be prompted to answer a question about saving electricity. The question is multiple choice and all answers are correct.
- (c) You are then prompted to submit the Contest entry form by providing the following information: first & last name, email, phone number, and agreeing to these terms and conditions.

Anyone who carries out the steps described above and complies with these Contest Rules including but not limited to the eligibility requirements will be entered for a chance to win.
