

**BC HYDRO SPRING 2025: SMART ENERGY CONTEST**  
**OFFICIAL CONTEST RULES**  
**NO PURCHASE REQUIRED**

**1. CONTEST PERIOD:**

British Columbia Hydro and Power Authority (“**BC Hydro**”) Spring 2025: Smart Energy Contest (the “**Contest**”) begins on March 24, 2025 at 12:00 AM Pacific Time (“PT”) and ends on May 4, 2025 at 11:59 PM PT (the “**Contest Period**”).

**2. ELIGIBILITY:**

The Contest is open to all residents of British Columbia who have reached the age of nineteen (19) years at the time of entry and otherwise comply with these Official Contest Rules (the “**Contest Rules**”). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.
