

BC HYDRO COOL SUMMER SCAVENGER HUNT CONTEST OFFICIAL CONTEST RULES NO PURCHASE REQUIRED

1. **CONTEST PERIOD:**

British Columbia Hydro and Power Authority ("BC Hydro") Cool Summer Scavenger Hunt Contest (the "Contest") begins on July 4, 2022 at 12:00 AM Pacific Time ("PT") and ends on August 4, 2022 at 11:59 PM PT (the "Contest Period").

2. ELIGIBILITY:

The Contest is open to all residents of British Columbia who have reached the age of nineteen (19) years at the time of entry and otherwise comply with these Official Contest Rules (the "Contest Rules"). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

3. HOW TO ENTER:

NO PURCHASE REQUIRED. To enter for a chance to win, complete the following steps during the Contest Period:

- (a) Visit bchydro.com/coolsummer during the Contest Period.
- (b) Click on the clue number and you will be prompted to interact with a piece of content. You could be asked to watch a video, participate in a quiz or vote in a poll.
- (c) You are then prompted to submit the Contest entry form by providing the following information: first and last name and email address.
- (d) Completing each of the eight clue activities will give you a letter, which will collectively make up the "password" you will need to enter in order to be eligible for the Grand Prize.

Anyone who carries out the steps described above and complies with these Contest Rules including but not limited to the eligibility requirements will be entered for a chance to win. All Contest entries must be received by the end of the Contest Period. BC Hydro is not responsible for and accepts no liability for late, lost, misdirected, delayed, or incomplete entries.
