# BC HYDRO SPRING CONSERVATION CAMPAIGN CONTEST OFFICIAL CONTEST RULES NO PURCHASE REQUIRED

## 1. CONTEST PERIOD:

British Columbia Hydro and Power Authority ("BC Hydro") Spring Conservation Campaign 2022 Contest (the "Contest") begins on March 7, 2022 at 12:00 AM Pacific Time ("PT") and ends on April 17, 2022 at 11:59 PM PT (the "Contest Period").

The Contest is open to all residents of British Columbia who have reached the age of nineteen (19) years at the time of entry and otherwise comply with these Official Contest Rules (the "Contest Rules").
