BC HYDRO WINTER READY CONTEST

OFFICIAL CONTEST RULES

1. CONTEST PERIOD:

British Columbia Hydro and Power Authority ("BC Hydro") Winter Ready Contest (the "Contest") begins on November 12, 2018 at 8:00 a.m. Pacific Time ("PT") and ends on November 18, 2018 at 11:59 p.m. PT (the "Contest Period").

2. ELIGIBILITY:

NO PURCHASE REQUIRED. The Contest is open to all legal residents of British Columbia who have reached nineteen (19) years of age at the time of entry and otherwise comply with these Official Contest Rules (the "Rules"). Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

3. HOW TO ENTER:

To enter for a chance to win one of three prize packages, visit either @bchydro on Instagram, @bchydro on Twitter, or the BC Hydro Facebook page during the Contest Period. There are three ways to enter the Contest:

(a) on November 12 @bchydro on Instagram will post content about getting "Winter Ready" requesting that viewers (1) tag a friend in the comments (2) like the post; and (3) follow @bchydro on Instagram;

(b) on November 12 @bchydro on Twitter will post content about getting "Winter Ready" requesting that viewers (1) retweet the content (2) reply to our tweet with how they get winter ready; and (3) follow @bchydro on Twitter; or

(c) on November 12 the BC Hydro Facebook page will post content about getting "Winter Ready" requesting that viewers (1) like the content; and (2) comment how they get winter ready

Anyone who carries out any of the above using an Instagram, Twitter, or Facebook account and complies with the eligibility requirements will be entered for a chance to win. All Contest entries must be received by the end of the Contest Period. All entries become the property of BC Hydro and will be stored and destroyed in compliance with the Freedom of Information and Protection of Privacy Act. BC Hydro is not responsible for and accepts no liability for late, lost, misdirected, delayed, or incomplete entries.

Limit one entry per person. Any person who enters more than the allowable number of entries into the Contest using multiple user names or identities will be disqualified by BC Hydro, in its sole discretion.

4. PRIZES:

Three Prize Packages: Three (3) prize packages are available to be won. Each prize package consists of one (1) \$100 gift certificate to The Bay and either:

(a) One (1) Nest Wi-fi Smart Learning Thermostat for gas heated homes (model no. T3007EF, approximate retail value \$330)

OR

(b) Three (3) CaSa Caleo Wifi Smart Thermostats for electric heated homes (model no. CA-NA-240-SX, approximate retail value \$300)

Prizes are not transferable and must be accepted as awarded with no substitutions in cash or otherwise. BC Hydro reserves the right, in the event that any prize or any component of a prize cannot be awarded as described for any reason, to substitute another prize or component of a prize of equal or greater value, without liability. 5. WINNER SELECTION:

A random draw will be conducted on November 20, 2018 by BC Hydro to select one (1) entrant from all eligible Contest entries from @bchydro on Instagram, one (1) entrant from all eligible Contest entries from @bchydro on Twitter, and one (1) entrant from all eligible Contest entries from the BC Hydro Facebook page to each win a prize package. If the same winner is selected for any of social media platforms, BC Hydro will redraw for @bchydro on Twitter. If a second redraw is necessary, BC Hydro will redraw from the BC Hydro Facebook page. The chances of winning depend on the total number of eligible entries received.

The selected entrant will receive the prize that corresponds with the type of heating system in their home as set out above.

Before being declared a winner, the selected entrants will be contacted via their social media account and be required to send their name, address, email and phone number. Once contact information is provided, BC Hydro will contact the selected entrant who will be required to, (a) correctly answer a mathematical skill-testing question and (b) sign and return a Declaration, Consent and Release form in order to receive the prize. At least two (2) attempts will be made

over the two (2) days following the draw to contact the selected entrant.
