

BC HYDRO TEAM POWER SMART (TPS) SMART HOME CONTEST
OFFICIAL CONTEST RULES
NO PURCHASE REQUIRED

1. CONTEST PERIOD:

British Columbia Hydro and Power Authority (“**BC Hydro**”) Team Power Smart Smart Home Contest (the “**Contest**”) begins on June 2, 2021 at 12:00 a.m. Pacific Time (“PT”) and ends on July 28, 2021 at 11:59 p.m. PT (the “**Contest Period**”).

2. ELIGIBILITY:

The Contest is open to all residents of British Columbia who, at the time of entry:

- (a) are members of Team Power Smart;
- (b) have reached the age of nineteen (19) years;
- (c) have high speed internet coverage with a minimum speed of 15Mbps;
- (d) are the homeowners or have permission of their landlords prior to installation of the Prize; and
- (e) otherwise comply with these Official Contest Rules (the “**Contest Rules**”).

Employees of BC Hydro, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

3. HOW TO ENTER:

NO PURCHASE REQUIRED. To enter for a chance to win, complete the following steps during the Contest Period:

 - (i) Click on the link to the Contest provided in the e-mail;
 - (ii) Complete the required information in the entry form; and
 - (iii) Submit the entry form.
- (b) New Team Power Smart members:
 - (i) register to be a member of Team Power Smart;
 - (ii) on or after June 2, 2021, click on the ‘Member Toolbox’ section;
 - (iii) Click on the link to the Contest
 - (iv) Complete the required information in the entry form;
 - (v) and Submit the entry form.

Anyone who carries out the steps described above and complies with these Contest Rules including but not limited to the eligibility requirements will be entered for a chance to win. All Contest entries must be received by the end of the Contest Period. BC Hydro is not responsible for and accepts no liability for late, lost, misdirected, delayed, or incomplete entries.

LIMIT ONE (1) ENTRY PER PERSON. Any person who enters more than the allowable number of entries into the Contest and/or uses multiple names or identities will be disqualified by BC Hydro.

4. **PRIZES:**

The Prize

There are 5 prizes available to be won (each a “Prize”).

Each Prize consists of a three year subscription to TELUS SmartHome Security “Control” package which includes the following equipment and services and has a combined total approximate retail value of \$2,500:
